DISCOUNTS

Upfront: Somerville House offers a 2.5% upfront discount for the annual payment of tuition and boarding fees on, or prior to, Wednesday 14 January 2026. This discount is applied after all other concessions.

Sibling: Somerville House offers a 10% sibling discount to those families who have an older sibling attending a PMSA school. The sibling discount does not apply if any other scholarship, bursary or discount (exc upfront) is applied.

OTHER NOTES

- The Pre-Prep program is a government-approved kindergarten program, and enrolled students will receive 15 hours of free kindergarten per week for 38 weeks a year. The Free Kindy subsidy and any applicable Child Care Subsidy will appear as credits on the fee statement each quarter and will be offset against the published Pre-Prep fee.
- All fees and charges quoted are exclusive of Goods and Services Tax (GST), except for registration fees and a portion of boarding fees relating to the provision of meals, which both attract GST.
- The School Fees Policy is available on the School's website.
- Co-Curricular uniforms will need to be purchased separately depending on your student's area of interest.
- Fee schedules are reviewed and approved annually by the governing body and published in advance of the forthcoming calendar year. Fees may be subject to change without notice.
- A term's notice in writing, in accordance with the *Agreement with the School*, is required if the student is to be withdrawn from the School, otherwise one term's fee may be charged in lieu of notice.
- Fee Accounts issued will outline a variety of payment options. Credit card payment via Parent Lounge is our preferred payment method (Note: Surcharge of 1% applies). BPay is also available, as outlined on Fee Accounts. A cash limit of \$10,000 per fee statement applies.
